

GENERAL TERMS AND CONDITIONS

This website is operated by Mont Travelers; Trip & Travel Montenegro LLC, License number 546

These terms and conditions may be amended from time to time and apply to all of our services.

By accessing, browsing, using and/or completing a reservation/booking through our (mobile) website you acknowledge and agree to have read, understood and agreed to the terms and conditions set out below.

These general conditions do not apply to the sale of excursions organized by other tourist providers where Trip & Travel Montenegro with its all brands acts as an intermediary, and the passengers are bound by the general conditions of the organizer (Trip Advisor, Get Your Guide, Viator, etc)

Almost all of our tours are held outdoors, therefore affected by weather and traffic conditions, the situation on-premises and all other unforeseen circumstances and as such the tour guides may adjust the itinerary to optimize your experience.

Agency reserves the right to change the date of departure in case of unfavorable weather conditions. In case of unfavorable weather conditions, the Agency will organize the excursion on the next suitable day or will provide a full refund to consumers. Please bear in mind that our client's safety is our first concern.

Offered services are presented on one of our websites with detailed descriptions and photographs. For tailor-made tours, the itinerary will be described and precisely in emails as well as in Confirmation Receipt/ Voucher and it will be noted as a final and accepted offer or in the absence of the same, these conditions will be considered valid. With written confirmation, we guarantee all services as per our program.

Additional information may be requested via email regarding any tourist services for which the company is registered.

All additional changes must also be made in writing and marked clearly on the original booking form where the original booking was made. All additional changes have to be made at least one week before departure, thus our pro forma invoice and program can be changed accordingly. For changes made less than a week before departure, we cannot guarantee it will be changed and accepted but we promise we will give our best trying.

All adventure tours and outdoor activities carry inherent risks and Trip & Travel Montenegro with brands or its partners do not assume any responsibility for accidents that are caused by its customers or can be traced to their own actions or are caused by factors outside of human control (Force majeure).

With the purchase of your trip you agree to these conditions, understand its implications and accept responsibility for your participation in your trip. Depending on the excursion, you may be requested to sign an additional liability release or advice to buy an extra incurrence policy, etc.

Travelers under 18 years must be accompanied by an adult.

If you allow, during the tour, your tour guide may take photographs and films of you (as part of a group) while you are a passenger and these may be used in our brochures, advertising and publicity material and/or social networks with Customers consent.

The Agency is not responsible for lost, damaged or stolen luggage or personal belongings during the tour. Lost or stolen luggage is to be reported to the tour guide or to the relevant police station.

The contents and formats on these websites, with the exception of the parts of text and pictures that have no commercial character and are exclusively meant for the purpose of guest information and the promotion of tourist services in Montenegro, are owned by the Agency. The contents may be copied only for noncommercial purposes and for individual use, respecting all copyrights and owner's rights.

The final price is definitely from the moment of the final booking by passengers. New/changed price on the website will not affect the already accepted price for the same service. No secret costs.

Payment can be done by credit card or via bank transfer except Customer will receive Agency bank account information and Invoice by e-mail and will have two working days to make the payment and to send us a payment confirmation. Upon receiving the payment, the Agency will send to Customer the confirmation (Voucher) or email and all the details regarding the tour. We ask that all international transfers to us be made with the OUR instruction, which means that all bank charges are to be paid by Customer.

Customers are provided with invoices that include VAT according to the Montenegrin law.

Please note that all prices for the services provided by Trip & Travel Montenegro LLC and its sub-brands (Mont Travelers) are in the company's local currency, EURO. As a local operator, the Agency cannot be responsible for currency fluctuations and or additional fees outside its control that may be applied such as bank transfer fees, credit card fees and etc.

We reserve the right to refuse participation to clients we believe are under the influence of alcohol or drugs, in such circumstances, no refund shall be given. Our guides reserve the right to refuse participation to any customer whose conduct or manner is likely to cause offense, upset or put other passengers in danger. In such cases, full cancellation charges apply.

Shall you feel unsatisfied with any service Agency has provided, please notify management team to avoid the potential for similar problems happening again during your tour, please email management@tripandtravel.me Please note that all complaints must reach Trip and Travel Montenegro within 2 days from the completion of your tour. Otherwise, possible compensation is not valid.

CANCELATION POLICY

We would deeply regret your decision to cancel your tour, however, we realize that there are many valid reasons that this can happen. In the event of cancellation, If the program does not specify otherwise, the below-written cancellation conditions apply:

1. CANCELATION OF ONE-DAY TOURS:

- **No show** - no refund, 100% non-refundable.
- **Less than 72 hours** - You will be refunded 50% of the total tour price. 50% is non-refundable, as this represents our direct cost of booking and preparing your tour.
- **More than 72 but less than 7 days** - You will be refunded 75% of the total tour price. 25% is non-refundable, as this represents our direct cost of booking and preparing your tour.
- **More than 7 days** - You will be refunded 100% of the total tour price.

Unexpected situations:

- **Weather conditions** can affect the tour safety, especially for cruise ship passengers so we will refund 100% of the total tour due to the inability to disembark from the ship.
- **Port cancellation** - Excursion will automatically be canceled and 100% refunds processed back to the form of payment that was used for the purchase or, if you request it, will work to accommodate you on another tour/another date.
- **The disembarkation delay** - your guide will try to get information about the disembarkation and change the beginning of the tour that might affect the itinerary. If you are not able to find your guide please call the office.

If for any reason the tour is canceled from the Agency, you will be fully refunded for the entire cost of your tour. In the case of a refund, at your request or the third side involved (cruise ship, air company,...) all bank transaction costs must be covered by your side. One day tour is one tour booked under the one name.

2. CANCELATION OF MULTI-DAY TOURS & SAILING TOURS

- No show, no refund, 100% non-refundable.
- Less than 15 days 50%
- More than 15 days before the tour, You will be refunded 75% of the total tour price. 25% is non-refundable, as this represents our direct cost of booking and preparing your tour.

Transaction fees are on your account. You always can choose to keep the reservation for another time.

If for any reason the tour is canceled from the Agency, you will be fully refunded for the entire cost of your tour. In the case of a refund, at your request or the third side involved all bank transaction costs must be covered by your side. For multiple one-day tours booked under the same name, the cancellation policy will be governed by the terms and conditions applicable to multi-day tours.

3. **CANCELATION OF AIRPORT TRANSFERS/TRANSFERS**

- **No show** - no refund, 100% non-refundable.
- **Less than 2 day** - You will be refunded 80% of the total tour price. 20% is non-refundable as this represents our direct cost of booking and preparing your transfer service.
- **More than 2 day** - You will be refunded 100% of the total price.

Unexpected situations:

- **Landing cancelation** - You will be refunded 100% of the total price or you can change the details of the reservation for another time.
- **Landing delay** - the driver will try to set the correct time of the meeting, checking the flight according to the flight number you shared with us at booking request. If you are not able to find the driver, please call our office.

If for any reason the tour is canceled from the Agency, you will be fully refunded for the entire cost of your tour. In the case of a refund, at your request or the third side involved (cruise ship, air company,...) all bank transaction costs must be covered by your side.

IMPORTANT INFORMATION REGARDING INSURANCE COVERAGE

Dear valued guests, at Trip & Travel Montenegro Tour Company, we prioritize the safety and well-being of our guests. While we have our own insurance policy in accordance with the laws of the country where we operate as a tour operator, it's important to note that our services often involve partnerships with other providers such as transportation companies, rafting, boat/sailing agencies... We ensure that all our partners meet the necessary safety standards and maintain appropriate insurance coverage.

However, we highly recommend that all travelers obtain additional travel insurance before departing from their home countries. This extra coverage can provide added protection in case of unforeseen circumstances during your travels.

Your safety and peace of mind are our top priorities, and we are committed to providing you with a memorable and worry-free travel experience.

ATTENTION

Sometimes the Agency uses the third-party service as a vehicle, boats, quads, rafting or paragliding equipment etc. and in this case, we guarantee we choose the best in the country but all possible disadvantages are responsibility of the third part. Technical problems are always possible, but being reasonable, it is not possible to control the air-cool level for every trip, and etc.

By booking the tour/our service, we consider that you agree to our terms and conditions outlined in the Terms & Conditions document, including any changes if mentioned in the email before confirmation of the reservation.

Regardless of the above cancellation policy, the policy might be different if it is written in a travel or contract program by our travel agent what depend on special partners and a third party.

All disputes will be subject to the jurisdiction of the court in Podgorica, Montenegro.

OUR GUARANTEES

If any tour, not just shore excursions, is cancelled because of a 'force majeure' event, you will receive a full refund. For shore excursions, this typically means such things weather conditions preventing your ship from docking, or if your ship arrives late or otherwise does not dock.

Trip & Travel Montenegro (Mont Travelers) guarantees that in the unlikely event that you miss your ship, we will arrange overnight accommodation and/or transport to the next feasible port-of-call.

Dear guests, we will take care of the quality of the tour, take care of you as much as possible but we hope we can account on good faith and trust between all parties.
